

## Monthly values of cross-border transmission capacity

PSE S.A. publishes herewith values of cross-border monthly transmission capacity which was calculated with consideration of transmission system security standards and with respect to operating procedure and planning. The publication has been prepared based on monthly transmission grid maintenance schedule. The estimation is preliminary and will be updated according to daily maintenance schedules.

Regarding import, the volume is determined taking into account the calculated NTCs and the difference between negative reserve level, and the required negative reserve level.
